



SARTELL LABOR FORCE DEMOGRAPHICS

- 76.2% LFPR compared to 69.9% statewide
- 47% of workers have a bachelors degree or higher (37% for Minnesota)
- More female workers than male workers unlike Minnesota in general
- Household income is higher than typical for all types
 Sartell = \$74,391, MN average = \$65,599
